

FIBA'S ROLE IN THE HONOURING OF BAT AWARDS







PAYMENT PLANS IMPOSED BY FIBA

FIBA'S DISCRETION



THERE IS NO
"RIGHT" TO OBTAIN
A PAYMENT PLAN

first instalment constitutes a minimum of 30% of the total amount due



Following the payment of the first instalment the club benefits from a provisional lift of the ban on registration of new players



IF breach of the payment plan, ban immediately reinstated and automatic fine imposed by FIBA (amount fixed in advance)

BENEFITS FROM PAYMENT PLANS IMPOSITION BY FIBA

Reduce the risk of a claimant losing money for going to BAT

ALLOWS A SWIFT PARTIAL PAYMENT


CAN SOLVE UNREASONABLE CONFLICT

FINANCIAL COERCIVE MEASURES USUALLY **SUFFICIENT**

losing party willing to pay in a few instalments but winning party would rather see losing party filing for bankruptcy


MAIN FLAW OF THE PAYMENT PLAN SYSTEM

TESTING PHASE ONGOING BUT VARIOUS CHALLENGES

ADVANTAGES OF SUCH PROPOSED ENFORCEMENT TOOL	CHALLENGES
 Players protection reinforced Players will be aware that they are signing in a club that has financial debts. Which might discourage them 	 Players personally affected (suspended) despite not being at fault Players to be informed upon signature
 Club incentive to pay the BAT Awards Clubs will have to ensure that payment of BAT Awards are prioritize to avoid losing attractivity towards players that will not take the risk to have their license suspended. UPCOMING AMENDMENTS OF THE FIBA IR

REGULATIONS TO BE AMENDED

CURRENT PROVISION

In the event that a National Member Federation, club, player, coach or agent participating in a BAT arbitration (the "first party") fails to honour a final award, order or any provisional or conservatory measures (collectively, the "decision") of BAT or CAS, the party seeking the honouring of such decision award (the "second party") shall have the right to request that FIBA sanctions the first party, subject to article 3-315.e.

The sanctions that FIBA may impose are the following:

- a. A monetary fine of up to CHF 150,000. This fine can be applied more than once; and/or
- Withdrawal of the FIBA license if the first party is a player's agent or of the WABC membership if the first party is a coach; and/or
- c. A ban on international transfers if the first party is a player; and/or
- d. A ban on participation in international competitions with the player's national team and/or club if the first party is a player; and/or
- e. A ban on registration of new players and/or a ban on participation in international club competitions if the first party is a club.

The above sanctions can be applied cumulatively and more than once.

The above sanctions can be extended, in FIBA's sole discretion, to natural or legal persons that are directly or indirectly linked to the first party, either from a legal or a sporting perspective. In particular, such linkage exists if the relevant natural or legal person is, or reasonably appears to be, a legal or sporting successor of the first party, which may include, without limitation, a consideration of the following: its headquarters, stadium, name, team colours, players, coaches, management, ownership, websites, social media channels, and/or public statements.

FUTURE ADDITION

if approved by the FIBA Central Board

FIBA may at its discretion

- (i) provisionally lift a ban, or
- (ii) refrain from imposing a ban, in each case subject to the first party's compliance with conditions that may be imposed by FIBA, including without limitation, respecting a payment plan for the first party's financial liability arising from a BAT or CAS award. FIBA may impose additional consequences in case of non-compliance with such conditions, without limitation including additional sanctions or national-level sanctions (in collaboration with the relevant National *Member Federation).*





ENFORCEMENT AGAINST A CLUB





- Top level club
- Many players signed before requesting a lift
- Various payment plan breached in the past
- Mid-level club
- Never had a BAT Award in the past
- Proactively contacts FIBA to address the bans prior to signing any players

NO POSSIBLE COMPARISION



- * Risk of a player failing to honour a BAT Award is higher
- Clubs need to register new players at some point
- Clubs can no longer circumvent a ban by creating a new entity
- ❖ NF can assist FIBA with additional sanctions against clubs

- Transfer outside FIBA jurisdiction
- Player Retires
- Finish his career without transferring

DEADLINES AND TIMELINES



Request for enforcement	Deadline in warning letters	Sanction following an elapsed warning deadline	Additional sanctions
up to 6 weeks*	1 week*	Usually within 24 h*	Case by case basis

- ❖ FIBA tries to keep a consistent approach but remains substantially influenced by the workload (e.g. eligibility, transfer season etc.)
 - Admin support should help in the future
- * Realistically not possible to establish clear deadlines
 - FIBA would not be able to abide by strict deadlines at this time
 - Need for discretion depending on the cases





ENFORCEMENT AT NATIONAL LEVEL



❖ NO DIRECT JURISDICTION OVER NATIONAL TRANSFERS



- Preventing internal transfer if players was not licensed without interruption with the same NF since the date of the ban.
- Requesting the NF to take sufficient measures to ensure the honouring of the ban (+ threat of disciplinary sanctions against NF).

No agreement but it does not mean that the LOC process is fully ignored



Recent case of a LOC being refused because of a banned player

Difficult situation if sanctions imposed when player already playing in such outside organisation
